



LOCATION

Great Eccleston is an idyllic village set in Lancashire on the Fylde Coast. The village, which was named one of the "most desirable" villages in the UK in a recent Telegraph article, lies to the south of the River Wyre and the A586 road, approximately 6 miles from Junction 3 of the M55.

Copp Meadow is situated on the edge of the village. The new development is easily accessed off Copp Lane and the village centre is within a very short walk. The development benefits from good transport links to the wider region.
